**NOTICE OF ELECTION**

#### **NUMBER OF SEATS**

1. The number of seats to be filled from amongst Advocates shall be **EIGHTEEN (18)**.
2. The number of seats to be filled from amongst FEMALE Advocates shall be **SEVEN (7)** out of which **TWO (2)** shall be by way of NOMINATION by Bar Council of India.

As per Gazette of India dated 20<sup>th</sup> September, 2022 under the "Bar Council of India Uniform Rules ( and Guidelines) for the elections of Bar Council, 2016", Chapter III, Rule titled : "Office Bearers of Bar Associations ineligible to be the Members of Bar Council"- An Advocate, who is an office bearer of any Bar Association ( Except Supreme Court Bar Association) shall not be eligible to contest the election of State Bar Council. However, if such Office Bearer has already resigned from his post before the date of notification of elections of State Bar Council, he shall be entitled to contest the elections of State Bar Council.

The Returning Officer shall reject the nomination paper of any such persons who were / are office bearers of any Bar Association on the date of notification of elections of concerned State Bar Councils.



## **NOMINATIONS**

The Nomination forms may be obtained from the office of the Karnataka State Bar Council, Old Election Commission Building, Bengaluru-560001, during office hours on all working days.

Nominations in the prescribed form (FORM-A) shall be personally delivered to the Secretary on or before **10.2.2026 upto 4-00 p.m.**

Every nomination shall be accompanied by a **DEMAND DRAFT** for a sum of **Rs. 1,25,000/- (One Lakh Twenty Five Thousand Only)** drawn in favour of "**SECRETARY, KARNATAKA STATE BAR COUNCIL**" payable at Bengaluru **within 4.00 p.m.**

The said fee shall be refundable only if the Candidates withdraws his/her candidature on or before the prescribed last date for withdrawal.
