WELFARE FUND ANNUAL SUBSCRIPTION CIRCULAR

This is to inform all the Members of Legal fraternity to pay annual subscription within **31st December, 2025** as per the Amended Act of KAWF which came into effect from 12th June, 2017:-

Advocates enrolled upto 31.12.2010	Rs. 2000/-
Advocates enrolled from 1.1.2008 upto 31.12.2024	Rs. 1000/-

Individual Advocates may pay the subscription through ONLINE through Official Website : ksbc.org.in

It is also provided that such subscription can be paid within **Six Months** after the due date with a penalty of **Rs. 100/- per month. (till 30th June, 2026)**

Subscription cannot be paid for the Previous Year i.e., 2010 to 2024

Those Advocates who have put in more than 15 years of practice may become the Life Member by paying **ONE TIME PAYMENT** of **Rs. 25,000/-** instead of paying Rs. 2,000/- each year. **Rs. 25,000/-** must be paid by way of **DD** drawn in favour of **Secretary, KAWF - TC.**

The Advocates who have already paid a sum of Rs. 15,000/- towards Life Membership have to pay the **DIFFERENCE AMOUNT** of **RS. 18,500** before **31st December 2025** (**Rs. 10,000/-** (Difference Amount) + **Rs. 8,500** (Late Fee is from June 2018). Those Advocates have to bring the original Life Membership Certificate alongwith DD in favour of "**Secretary, K.A.W.F.T.C.**" Payment will be accepted only through D.D.

We also request all the Presidents of Bar Associations to assist the Advocates of your Bar to pay the Subscription in time and requested to display the same on the **NOTICE BOARD** of your Association.

Procedure for payment of subscription through ONLINE.

1. Open the Official Website you can find in red colour words "ONLINE PAYMENT" on the right side of the screen.
2. Enter Roll Number and click on word "**SEARCH**"
3. Name and address will be displayed
4. Double click on the name
5. Full details will be displayed
6. Verify the column **Subscription Amount Pending** shown in red colour
7. Click on the word "**PAY**"
8. Transaction Details will be displayed, click on the word "**Proceed to Pay**"
9. Select mode of payment and enter details required and click the word "**MAKE PAYMENT**"
10. **OTP** will be generated in your mobile which is linked to your Account number.
11. Enter the OTP number and click on the word "**Make Payment**"
12. Receipt will be generated after payment.
13. You will receive SMS from your Bank.
