WELFARE FUND ANNUAL SUBSCRIPTION CIRCULAR

This is to inform all the Members of Legal fraternity to pay annual subscription within **31st December, 2021** as per the Amended Act of KAWF which came into effect from 12th June, 2017:-

Advocates enrolled upto **31.12.2006** **Rs. 2000/-**

Advocates enrolled from **1.1.2007**
upto 31.12.2020 **Rs. 1000/-**

It is also provided that such subscription can be paid within **Six Months** after the due date with a penalty of **Rs. 100/- per month. (till 30th June, 2022)**
Subscription cannot be paid for the previous years 2010-2020.


Those Advocates who have already paid a sum of Rs. 15,000/- towards Life Membership have to pay the **DIFFERENCE AMOUNT** of **RS. 13,700/-** by way of Cash which includes late fee of Rs. 100/- p.m. w.e.f. June 2018 upto December 2021 (**Rs. 10,000/-** (Difference Amount) + **Rs. 3,700/-** (Late Fee). Advocates who have already paid Rs. 15,000/- have to bring the original Life Membership Certificate along with Cash.

Advocates are requested to pay only in the Cash Counter after verification and the office copy to be dropped in the box placed near the Cash Counter. No other mode of payment shall not be accepted. **No Advocates shall pay the subscription in the Bank Account as the said Account is closed and same cannot be considered.**

The Bar Council has started ONLINE PAYMENT OF SUBSCRIPTION. Hence individual Advocates may pay the subscription through ONLINE from our website : ksbc.org.in

Procedure for payment of subscription through ONLINE

- 1 On opening of our website, you can find in red colour words" **ONLINE PAYMENT**" on the right side of the screen.
- 2 Enter Roll Number and click on word "**SEARCH**"
- 3 Name and address will be displayed.
- 4 Double click on your name
- 5 Full details will be displayed..
- 6 Verify the column **Subscription Amount pending** shown in red colour.
- 7 Click on the word "**PAY**"
- 8 Transaction Details will be displayed, click on the words "**Proceed to Pay**"
- 9 Select mode of payment and enter details required and click the word "**MAKE PAYMENT**"
- 10 **OTP** will be generated in your mobile which is linked to your account number.
- 11 Enter the **OTP** number and click on the word "**Make Payment**"
- 12 Receipt will be generated.
- 13 You will receive **SMS** from your Bank.
